POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 27 JUNE 2016

Reference is made to the annual results announcement for the year ended 31 December 2015 of C.banner International Holdings Limited (the “**Company**”) dated 15 March 2016 and the circular of the Company (the “**Circular**”) incorporating, amongst others, the notice (the “**Notice**”) of annual general meeting of the Company (the “**AGM**”) dated 29 April 2016. Unless the context otherwise requires, capitalised terms used herein shall have the same meanings as those defined in the Circular.

2016 ANNUAL GENERAL MEETING

At the AGM held on 27 June 2016, all the proposed resolutions as set out in the Notice were taken by poll.

As at the date of the AGM, the total number of issued shares of the Company was 2,082,000,000 Shares, which was the total number of Shares entitling the Shareholders to attend and vote for or against the resolutions proposed at the AGM. There was no restriction on any Shareholder casting votes on any of the proposed resolutions at the AGM. There was no Share entitling the Shareholders to attend and vote only against the proposed resolutions at the AGM. No party has stated its intention in the Circular that it would vote against any proposed resolution or that it would abstain from voting at the AGM.

The Company's Hong Kong branch share registrar, Computershare Hong Kong Investor Services Limited was appointed as the scrutineer at the AGM for the purpose of vote-taking. The poll results in respect of the respective resolutions proposed at the AGM were as follows:
