## **COMPLETION OF ISSUE OF CONVERTIBLE BONDS AND NOTES**

Reference is made to the announcements of the Company dated July 20, 2017 and July 26, 2017 in relation to the issue of the Convertible Bonds and the Notes pursuant to the Subscription Agreement (the “**Announcements**”). Unless otherwise defined, capitalized terms used herein shall have the same meanings as defined in the Announcements.

## **COMPLETION OF ISSUE OF CONVERTIBLE BONDS AND NOTES**

The Board is pleased to announce that all the conditions precedent under the Subscription Agreement have been fulfilled and the Completion took place on August 4, 2017.

The Convertible Bonds and the Notes, each in the principal amount of US\$50 million (equivalent to approximately HK\$390,235,000), were issued to the Subscriber on August 4, 2017. Each of the net proceeds arising from the issue of the Convertible Bonds and the Notes, after deduction of expenses, will amount to approximately HK\$389,455,000 respectively, which shall be applied to replenish the working capital of the Company and cater for potential desirable acquisitions.

The approval for the listing of, and the permission to deal in, the 108,963,585 Conversion Shares upon conversion of the Convertible Bonds has been granted by the Listing Committee of the Stock Exchange.

To the best of the Directors’ knowledge, information and belief having made all reasonable enquiry, each of the Subscriber and its ultimate beneficial owner(s) (if applicable) are Independent Third Parties.
