On 18 May 2012, the Company entered into the Convertible Bonds Subscription Agreement (“CB Agreement”) with China Consumer Capital Fund, L.P, China Champion Holdings Limited and MousseDragon, L.P (“CB Subscribers”) in relation to the issue of the convertible bonds in an aggregate principal amount of RMB189,024,450 which are convertible into shares of the Company at an initial conversion price of HK\$2.40 per share, details of which are disclosed in the announcement of the Company dated 18 May 2012.

As further disclosed in the announcement of the Company dated 15 June 2012, all the conditions precedent under the CB Agreement had been fulfilled/waived and the convertible bonds were issued to CB Subscribers on 15 June 2012.
